## Interpretation:

The NCAA Division III Interpretations and Legislation Committee determined that any **contest** between two or more Division III institutions must be classified (e.g., scrimmage, exhibition, regular-season **contest**) the same by all participating Division III institutions (as opposed to a **contest** against a non-Division III opponent which may be classified differently). Further, an institution is not permitted to change the classification of a given **contest** after that **contest** has commenced.
