# August/September 2017

### **Permissible**

## August 1 - September 8 QUIET PERIOD

Beginning September 1 unlimited telephone calls and electronic correspondence to junior and senior prospective student-athletes.

## Sept 9-29 CONTACT

In-person, off-campus contact with seniors.

## Sept 23-24 (Saturday and Sunday)

ALL evaluations, including those permitted at certified nonscholastic women's basketball events, count in the 112 permissible recruiting person days. \*\* If an event is conducted on consecutive days in a tournament format, an institution would only be charged with a single recruiting opportunity per PSA.

### Sept 30 EVALUATION

Evaluate off-campus at regular scholastic events.

All institutional women's/girl's camps and clinics shall offer the SAME participation, registration procedure, fee structure, advertisement and /or logistical experience. (e.g., lodging, meals, awards)

Institutional coaching staff members to engage in recruiting activities (tours, academic advisors) with PSA's during institutional camps or clinics.

For up to two coaching staff members per institution per calendar day to attend national team and junior national team training and tryout events conducted outside the permissible contact and evaluation periods.

For an incoming SA (freshman or transfer) to represent an institution on a foreign tour that occurs during the summer prior to initial full-time enrollment provided she is eligible to represent the institution during the academic year immediately following the foreign tour.

To permit on-campus contact between former SA and a PSA, or her relatives and other individuals.

Athletics department staff members may make telephone calls and send electronic correspondence to a PSA beginning the day immediately preceding the unofficial visit until conclusion of the visit.

For a non-coaching staff member or coach who does not count towards the limitations to make unlimited calls to PSA during the 5 days immediately preceding the PSA official visit.

#### **NOT Permissible**

Contact with seniors during a school day when classes are in session.

In-person, off-campus contact with freshman, sophomores or JUNIORS. Contact with juniors begins March 1, 2018.

Evaluation on Friday at a certified nonscholastic women's basketball event.

Calls to PSAs on day or days of competition until they have been released at the end of event.

Institution or staff member to employ (paid or volunteer basis) an individual associated with a recruited prospective student-athlete (IAWRP) at an institutional camp or clinic.

During a two-year period before a recruited PSA's anticipated enrollment and two-year period after actual enrollment, for institution to employ (or enter into a contract for future employment with) an IAWRP in any athletics dept noncoaching staff position or strength and conditioning position.

To attend an event that the national governing body does not consider a tryout or training event in order for an individual to make the national team or an event not specified elite or junior level international.

In-person contact with PSA, relatives or legal guardians during day of competition. Before OR AFTER.

To evaluate in Hawaii outside of the recruiting calendar.

To not count every recruiting person day outside of July evaluation period.

To attend regional championships that are approved, sponsored or conducted by FIBA outside permissible recruiting and evaluation periods. This rule applies to men's basketball ONLY.
