NCAA staff has received several questions regarding which events women's basketball coaches may attend outside of permissible contact and evaluation periods. To determine if a coach may evaluate at an event outside of a permissible contact and evaluation period, apply the following analysis:

1. Does the national governing body consider the event a tryout or training event (e.g., training camps, mini-camps, tryouts, competition) in order for an individual to make the national team? [NCAA Bylaw 13.1.7.6.6]

If yes, coaches may attend the event outside of a permissible contact and evaluation period.

Please note: For the purposes of Bylaw 13.1.7.6.6, competition refers to intra-squad competition at a tryout or training event or competition against outside teams that the national governing body has officially designated as a tryout or training event. Generally, competition at events where the national team roster has already been determined would not be considered training or tryouts (e.g., FIBA 3X3 World Cup).

2. Is it an Olympic, Pan American, World Championships, World Cup, World University Games (Universide) or World University Championship competition or the junior level equivalent competition (e.g., Youth Olympic Games)? [Bylaw 13.1.7.15]

If yes, coaches may attend the event outside of a permissible contact and evaluation period.

Please note: Other elite and international events not explicitly mentioned above (e.g., U18 European Championships) do not qualify.

The following chart, which includes past and future events, has been updated to assist the membership in its ongoing evaluation of events. Additionally, the highlighted event has been added to provide additional clarification to the membership.

June 20-27, 2017	FIBA 3x3 Women's U18 National Team Training Camp	No.	Permissible per Bylaw 13.1.7.6.6; however, USA Basketball has indicated it will close these sessions to NCAA Division I coaches due to space limitations and to allow for national team preparations.

June 28-July 2, 2017	FIBA 3x3 World Cup for U18 Women (Chengdu, China)	Yes.	Elite or junior level international event (Bylaw 13.1.7.15).
July 7-21, 2017	U19 National Team Training Camp (USOTC and Italy)	Yes.	National team training or tryout event (Bylaw 13.1.7.6.6). Open sessions will be identified closer to the start of training camp.
July 22-30, 2017	FIBA U19 World Cup (Udine, Italy)	Yes.	Elite or junior level international event (Bylaw 13.1.7.15).
July 31-August 11, 2017	U23 National Team Training Camp (USOTC and Tokyo)	Yes.	National team training or tryout event (Bylaw 13.1.7.6.6). Open sessions will be identified closer to the start of training camp.
August 4-13, 2017	FIBA U18 European Championship (Dublin, Ireland)	No.	Not a national team training or tryout event; not a specified elite or junior level international event.
August 12-15, 2017	U23 International Tournament (Tokyo) – hosted by the Japan Basketball Federation	No.	Not a national team training or tryout event; not a specified elite or junior level international event.

Finally, Bylaw 13.1.7.5.6 (regional championships approved, sponsored or conducted by FIBA) does not apply to women's basketball.
