

Subject: Application of NCAA Division I Proposal No. 2016-35 Recruiting -- Evaluations -- Women's Basketball -- Attendance at National Team Tryouts and Proposal No. 2016-39 Recruiting -- Evaluations -- Basketball -- National Team Activities.

Following the April 2017 NCAA Division I Council meeting, the conference sponsor of Proposal No. 2016-35 clarified the proposal was intended to apply to any organized training and tryout activity (e.g. training camps, mini-camps, tryouts, competition) involving national teams or junior level national teams. In that regard, it has been determined the adoption of Proposal No. 2016-35 has rendered Proposal No. 2016-39 moot for women's basketball and the new legislation goes into effect immediately. Therefore, there is a limit of two coaches per institution per day who may attend such training and tryout activities outside a permissible evaluation period. LSDBi has been updated to reflect these changes.

To assist the membership, the NCAA academic and membership affairs staff has collaborated with USA Basketball to provide a list of events women's basketball coaches may or may not attend in the upcoming months. It is important to note that the list is not exhaustive and even though NCAA bylaws may permit coaches to attend an event, the governing body may limit coaches' attendance due to the importance of proper national team preparations and gym space limitations. Please note, the staff is currently working with USA Basketball regarding similar events for men's basketball that occur in June and July. This information will be distributed for men's basketball once the dates and locations for their events are finalized.

Date	Event Name	May Coaches Attend to Evaluate Prospects?
May 18-21, 2017	U19 National Team Trials (Colorado Springs US Olympic Training Center - USOTC)	Yes – USA Basketball has indicated all sessions will be open only to one NCAA Division I coach per institution per day.
May 25-June 6, 2017	U16 National Team Trials and Training Camp	No -- NCAA legislation would permit attendance; however, USA Basketball has indicated it will close these sessions to NCAA Division I coaches due to space limitations and to allow for national team preparations.
June 7-11, 2017	FIBA Americas U16 Championship (Buenos Aires, Argentina)	No – not permitted by NCAA legislation.
June 20-27, 2017	FIBA 3x3 Women's U18 National Team Training Camp	No -- NCAA legislation would permit attendance; however, USA Basketball has indicated it will close these sessions to NCAA Division I coaches due to space limitations and to allow for national team preparations.

June 28-July 2, 2017	FIBA 3x3 World Cup for U18 Women (Chengdu, China)	Yes
July 7-21, 2017	U19 National Team Training Camp (USOTC and Italy)	Yes -- open sessions will be identified closer to the start of training camp.
July 22-30, 2017	FIBA U19 World Cup (Udine, Italy)	Yes
July 31-August 11, 2017	U23 National Team Training Camp (USOTC and Tokyo)	Yes -- open sessions will be identified closer to the start of training camp.
August 12-15, 2017	U23 International Tournament (Tokyo) – hosted by the Japan Basketball Federation	No – not permitted by NCAA legislation.
