NCAA Division I Legislative Committee

NCAA Bylaw 14 Incorporations.

Over the next coming weeks, close to twenty former published interpretations will be incorporated into the NCAA Bylaw 14 portion of the NCAA Division I Manual. Over the last year, interpretations affiliated with Bylaw 14 legislation were reviewed, resulting in a portion identified as candidates for incorporation into the legislation. Over the past few months, the NCAA Division I Legislative Committee and the NCAA Division I Interpretations Committee collectively took action to review and approve the identified interpretations for incorporation in the Division I Manual. As a part of the normal incorporation process, a staff interpretation must be elevated to an official interpretation prior to becoming incorporated into the legislation. As a result, several official interpretations affiliated with staff interpretations will be issued and immediately archived as steps in this process. Any questions
