2012 State Farm/WBCA NCAA DIII Player of the Year Finalists Named

ATLANTA (March 16, 2012) – Caroline Stedman of Amherst College and Carissa Verkaik of Calvin College are the finalists for the 2012 State Farm®/WBCA Division III Player of the Year award, the Women's Basketball Coaches Association announced today.

State Farm and the WBCA present the player of the year award annually to the top player in each of the five WBCA membership divisions (NCAA Divisions II, III, NAIA, junior/college college and high school). The winner will be announced during the second annual WBCA Awards Show on Monday, April 2, in Denver. This event is part of the WBCA National Convention and is held in conjunction with the NCAA® Women's Final Four®.

"The WBCA is pleased to name Caroline and Carissa as the finalists for the State Farm/WBCA Division III Player of the Year award," said WBCA CEO Beth Bass. "These women have had outstanding seasons, and are very deserving of this achievement. State Farm is synonymous with excellence and so are these student-athletes' performances. Stedman, a 5-foot-10 guard from Walpole, Mass., averages 13.9 points per game for NCAA Division III No. 1 Amherst. The senior has played an incremental role in her team's success this season, leading them to a New England Small College Athletic Conference championship with 17 points and two steals. Stedman and the Lord Jeffs are vying for an NCAA Division III national championship and will face George Fox on March 16 in the Women's Final Four.

Verkaik, a 6-foot-2 forward from Holland, Mich., posts 19.2 points per game and pulls down 8.8 rebounds a contest for No. 5 Calvin. The junior averages 4.3 blocks a game, tallying 128 on the season. Verkaik was also named the D3hoops.com Great Lakes Region Player of the Year following her impressive season.

The State Farm/WBCA Player of the Year Award is selected by the 10-member WBCA Player of the Year Committee, which consists of one WBCA-member coach from each of the nine WBCA JC/CC Regions and the committee chair.
